Vendor Application and Event Policy

Exhibitor agrees to abide by and be subject to the following MVR/EDS Event Policies.

Application Deadline: Application Deadline is August 15, 2009.

Selection Process: EDS/MVR reserve the right to accept or reject entrants on the basis of the merchandise described and/or submitted. ***No Used or Flea market items permitted.***

Fees: The fee for an open air **10 x 10** single space is **\$50** for one day or **\$75** for both days.

The fee for a covered **10 x 10** single space is **\$100** for one day or **\$150** for both days.

Corner spaces are limited and will be assigned by EDS according to festival relevance.

Priority in space assignment will be given to vendors attending both days.

All payments are non-refundable, irrespective of weather conditions, rain or shine.

All spaces are vehicle accessible for setup, which you may begin after 1:00pm on Friday, Aug 21, 2009 and also between 8:00am and 11:00am on Saturday and Sunday, Aug 22 & 23.

Each vendor must properly secure all valuables including tents (with spikes and weights).

Participants are responsible for displaying, supervising, storing and selling their work.

Electricity will be available upon request, if so noted in the application and paid for.

All goods must be covered and secured overnight.

Space Assignments: All spaces are located on grass. Spaces are on a first come first serve basis. Come early! Each space will be provided with two admission wrist bands, 1 long table and 2 chairs ONLY. You may bring extra. EDS/MVR reserve the right to modify space assignments as may be required.

Vendor Parking: There is a designated parking lot for all Vendors. Handicapped vendor parking is in a designated location within the Vendor parking lot. The Vendor parking lot will accommodate all craft vendors as well as food concession vendors. Only vendors with MVR parking permits will be permitted entry to the Vendor parking area. Please use Vendor Entrance. Some vendors have special arrangements with the MVR for parking. It is the responsibility of the Vendor to negotiate any parking arrangements with the EDS or MVR. There is limited space in the Vendor parking lot for overnight camper parking. **No craft vendor vehicles or trailers will be permitted to park anywhere within the Craft Vendor Exhibit Area – there will be no exceptions.**

Late Entries: Will be accepted upon **prior notification** with **CASH** payments only day of festival. Receipts will be given the day of the Festival.

Exhibitors are responsible for collecting and reporting NY State and Local Sales Tax, currently 8%.

There are no rain dates in case of inclement weather.

Please do not leave behind any garbage or refuse at your booth.
